The Grand Baie Golf Club is a fun & friendly regional golf association promoting golf in the north and targeting Mauritians and Expats of all levels of ability primarily living in the north of Mauritius.

We were delighted with our first two years where there were more than 150 paid registered members at the end of December 2018, and nearly 200 paid registered members at the end of December 2019.

Three major championships were organised during the year. These were:

- **GBGC Tour:** order of merit on 6 individual competitions of which the 3 best ones have been selected.
- **GBGC Match play:** tournament by equipped of 2 in match-play formula $\frac{3}{4}$ hcp stableford
- **Interclub:** Tamarin Golf Club vs Grand Baie Golf Club friendly match hosted by GBGC in a Ryder Cup format

GBGC Tour: 171 different players participated (including members, invited sponsors and members' guests) in the GBGC Tour in 2019. Each tournament had two categories – 0-18 HC and 19-36 HC. Prizes were for the top 3 of each category, closest to the pins, longest drives (men and women), longest day and best Gross score. There was also a GBGC Tour league table with the best 3 scores to count over the course of the year with prizes for the top 3 of each category.
